New Salem Select Board Meeting

Minutes of June 26, 2023

Select Board members present: Sue Cloutier (SC), Zara Dowling (ZD)

SC noted that a police officer has suggested developing a bylaw regarding night activities on roads and other public places in New Salem. The suggestion was prompted by partying that has been occurring on Branch Bridge Road, but would apply to all town streets. The Select Board determined that such a bylaw would be a useful way to authorize New Salem police to stop a disruptive activity before it rises to the level of an arrestable offense.

ACTION: To begin this process, ZD will ask the police chief if there are any other towns' bylaws he would suggest as a basis for New Salem's.

During the public comment period, Stacey Senflug (S Main St) reiterated her comment from the previous Select Board meeting that she would like to have town streets cleaned as soon as possible, noting that some storm drains in town are completely blocked by dirt and debris. The Select Board discussed the usefulness of a regular schedule for this and other Highway Department tasks.

ACTION: SC will contact the Highway Department to see where the street cleaning issue stands and help to resolve it.

VOTE: ZD motioned to approve a one-day liquor license for the 1794 Meetinghouse for July 29, 2023. SC seconded. Passed unanimously.

The Select Board discussed approving new terms for town employees and committee **members.** The board noticed several issues with the approval paperwork they received. In some cases names and/or term expiration dates were not properly recorded. The board decided to proceed with the approvals of the correctly-filled forms at this meeting and return to the remaining ones in the future once they have been corrected.
